- Development of non-existing technologies that solve a public need
- Strong commitment of public user administration
- Elegible regions in Spain (Andalucía, Canarias, Castilla la Mancha,

Castilla y León, Comunidad Valenciana, Galicia y Extremadura)

- Prototype assignment CDTI/Public user
- Initial budget 100 M€ (ERDF + CDTI funds)



CALL FOR IDEAS



- Deadline: 30/05/2019
- 274 ideas
- Evaluation in two phases: elegibility and priorization
- Final results: 26 prioritized ideas.
- 7 finalist ideas that are already working on the signing of the collaboration agreement.

Preliminary consultations will be launched before the end of the year.





CALL FOR IDEAS...WHAT ARE WE SEARCHING FOR?

- New technologies that could meet spanish public users' needs
- Start: TRL 4-6. End: 6-7. Non validated tecnologies to reach real environment
- Strategic & social relevant projects/technologies
- Relevant projects (> 2 Million €).







ELIGIBLE PUBLIC USERS

- Great public need
- Strong commitment and own resources
- National Administrations or regional and local Administrations from a region with available ERDF funds.
- Only prototype validation: no use or commercial exploitation.







PUBLIC USERS' TASKS

- Collaboration Agreement signature
- Available in-kind resources for:
 - I. Market Consultation
 - II. Drafting tendering documents
 - III. Bids evaluation
 - IV. Certifications and follow up
- Responsible for prototype reception & validation









PRELIMINARY MARKET CONSULTATION
